Membership requirements:

- Payment of annual dues, based on type of membership.
- Up to (9) nine hours per month of gallery sitting first (6) six months, (6) six hours thereafter.
- After the first six months, performance on a Crew (3) three hours monthly, in support of gallery operations.
- Attendance at monthly general membership meetings, minimum 9 annually.

• Orientation with current members to gain understanding of gallery operations, policies, and procedures.

Membership entitles you to:

- Monthly exhibits of your work in the gallery.
- Portfolio on New Zone website.
- Opportunities to exhibit in other group venues.
- No charge participation in New Zone's special annual shows.
- Inclusion in all promotional and special events.
- Community with local artists, networking, educational opportunities and more.
- Opportunity to be a Featured or Spotlight Artist.

Membership categories:

- Regular -\$360/annual dues, standard Hosting and Crew schedule.
- Modified-Annual dues, modified Hosting and Crew schedule. PTNP
 - Other
- Patron-Annual dues, no artwork display, no Hosting and Crew schedule.

Application procedure:

Fill out the membership application and inquire about attending a Board meeting. At your scheduled Board meeting, bring a few samples of your work, ready to hang, as well as your Artist's Bio and anything else you'd like to share. If the size or bulk of your work makes that impractical you may bring photos that clearly show its scale and presentation. Your work must be presented in a professional manner suitable for gallery exhibitions.

The Board meetings start at 4:00 and new member presentations are first on the agenda. Once youare acceptedforNewZone membership, you will meet with a current New Zone member for an orientation. Thank you for your interest in New Zone!

Membership Categories and Modifications

_Regular Membership:

Regular members will pay \$360 per year in dues. Members of greater than one year may opt to make 2 payments of \$180 (payable in April and October).

New Regular members are expected to host 3 shifts per month for their first 6 months of membership. Following that, all Regular members are expected to host two shifts per month and work 3 or more hours on a crew (for the sales crew that means hosting 3 shifts). If no crew work is available in a given month, members are expected to host a third shift.

Pay-to-Not Play Memberships (PTNP):

_____Partial PTNP: A member may choose to pay \$360 in dues, plus \$360 per year in lieu of hosting **once** a month (\$720 total)

____Full PTNP: A member may choose to pay \$360 in dues, plus \$720 in lieu of hosting at all for the year. (\$1080 total)

____Total PTNP: A member may choose to pay \$1500 (total) in lieu of both hosting and crew work.

Legacy Membership: Legacy status is designed for long term members who are unable to fully participate. Status is determined on a case by case basis by the MMC*. Members pay \$360 in dues but are not required to host or crew.

_____Patron Membership: Patron members are accepted by the Board, on a case-by-case basis. They do not show art or vote, nor are they required to host or crew.

Modifications:

1. Crew leaders and Board Officers are not required to host or serve on other committees.

2. Board Members are required to host one time per month and serve on a crew.

3. The *MMC or the Board may modify the hosting and/or crew requirements temporarily or long term for a member who has extraordinary circumstances or takes on time consuming, significant special projects or responsibilities.

4. Financial Hardship: Upon approval of the Board, the *MMC may elect to admit a new member or allow a current member to pay \$120 in dues, host 4 times and participate on one crew (15 hrs per/mo of service).

5. <u>In kind</u> requests will be considered on a case-by-case basis by the Board. Member must present a written proposal to the MMC who will review it and present it to the Board. At minimum, in kind trades for hosting should be valued at \$360 for one shift per month or \$720 for 2 shifts per/mo. Trades for dues must value at least \$360 or more.

Modifications will be written on the back of each contract and signed by both the member and a Board representative. Modifications will be valid until the next Membership Contract Renewel (typically March).

The Committee will base their modification decisions on both the needs of the member and the New Zone's need for financial stability, consistency and fairness. All modifications will be transparent and viewable on Trudy.

*The role of the Membership Modification Committee (MMC) will be to review members' requests for modifications to Membership requirements, on a case by case basis. Members of the gallery may volunteer for the committee and the Board will appoint five, including one Board member. Because of current time constraints, the 2024 the current ad hoc committee MMC will continue through May, after which, new committee members will be appointed. The MMC is appointed for a 12 month term. The Committee will convene on an as needed basis. All decisions by the Committee may be appealed to the Board.
